**Registration:** Kids Derby Registration will be held on Friday, September 22nd, from 3pm to 7pm. Participants must register during this time to be eligible for the tournament.

- **Tournament Date:** The Kids Fishing Derby will take place on Saturday, September 23rd.

- **Age Groups:**

**A) Group #1:** Ages 10 to 14 years old.

Check-in Time: 7am to 8am.

Fishing Time: 8am to 9:30am.

**B) Group #2:** Ages 5 to 9 years old.

Check-in Time: 9am to 10am.

Fishing Time: 10am to 11:30am.

- **Fishing Equipment:** The tournament organizers will provide fishing equipment, including rods, reels, lines, hooks, and bait (to the first 150 participants per category, with a total of 300 participants) Participants are allowed to bring their own fishing equipment if desired.

- **Weigh-In:** The winners will be determined based on the heaviest fish caught, regardless of the fish species. To be eligible for weigh-in, participants must wear the wristband received at the registration.

- **Competition Format:** This is a head-to-head competition, where participants compete individually to catch the heaviest fish. (Excludes Stingray fish)

- **Donation:** The proceeds from this tournament will be donated to foundations that support children in the fight against cancer. Your participation will contribute to a meaningful cause. Kids helping Kids.

- **Sportsmanship:** Participants are expected to demonstrate good sportsmanship throughout the tournament. Respect for fellow participants, tournament officials, and the environment is mandatory.

- **Safety:** Participants must prioritize safety at all times. It is the responsibility of parents, guardians, or accompanying adults to ensure the safety of the participants, especially for younger children.

- **Environmental Awareness:** Participants are encouraged to practice catch and release whenever possible to promote the conservation of fish populations. Please be mindful of the environment and avoid littering.
